AT 5:30 SUPERVISOR HORTON CALLED THE TOWN BOARD MEETING TO ORDER FOLLOWED BY PRAYER AND PLEDGE.

SUPERVISOR HORTON REPORTED THAT SHE HAD RECEIVED THE FINAL PAYMENT OF @20,000.00 ON THE TOWN'S PARK GRANT.
