### Is your family enrolled in the Community Backpack Program?

Pick up your family's weekly backpack from 10 AM – noon on FRIDAYS.  
Your family's backpack will be at the building where your child is enrolled.  
Intermediate, High School and Middle School Backpacks will be located at the Middle School!

**Please note: Plans may be adjusted as circumstances change (food availability, staffing, travel restrictions, etc.).**
